








Students attended the lecture actively, and at the end of the lecture a few project topics were discussed with students. Project topics were allotted to students through LMS of College.

The lecture ended with Omkar asking questions to the FYBCBI students from the delivered lecture and students answering the same with promptness. Total Number of Students benefited were 25.



It was largely a webinar on financial and literary education. The real-time dynamics that pupils were exposed to improved their understanding well beyond textbooks and curriculum. The webinar began with students being virtually transported to a monetary museum, where they were shown a brief audio movie about the origins of cash and the evolution of money from the first piece of metal exchanged to the current system. 


#### **BRIEF REPORT**



The webinar engaged a total of 122 students from SYBAF, SYBMS, and SYBCOM. Mr. Probal Bhagat Sir, the next speaker, informed students about the Bharat Interface for Money (BHIM) App and how to use digital payment methods such as UPI (Unified Payment Interface), Google Pay, and Phonepe.
