

Brief Report


The Department of Commerce (Banking and Insurance) has organized Intra College PPT Competition on the occasion of Bank Nationalization Day via google meet.




FC Project Guidance Lecture







Student exchange program was organized for FYBCBI class, wherein a lecture was conducted by a student from SYBCBI. The lecture was scheduled at 8:00 am.



The Department of Banking and Insurance organized a Video Screening on the Working of Stock exchange for the first year, Second year and third year students.







BRIEF REPORT:


The Department of Banking and Insurance organized a Workshop on Overview of Capital Market for the first year, second year and third year students.


Guidance Lecture on Central Banking
