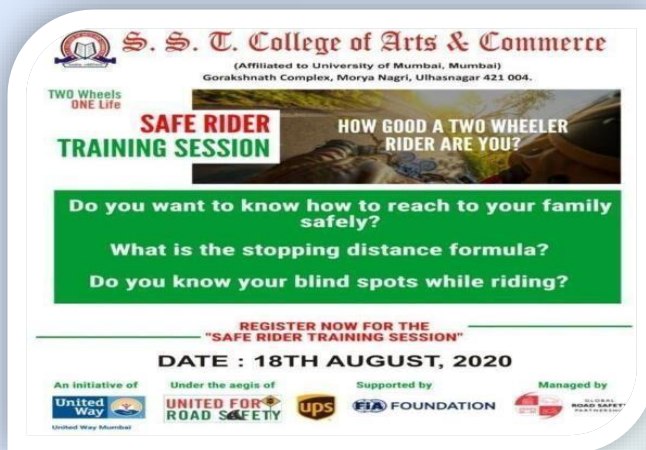

Brief Report on webinar on safe rider training session:

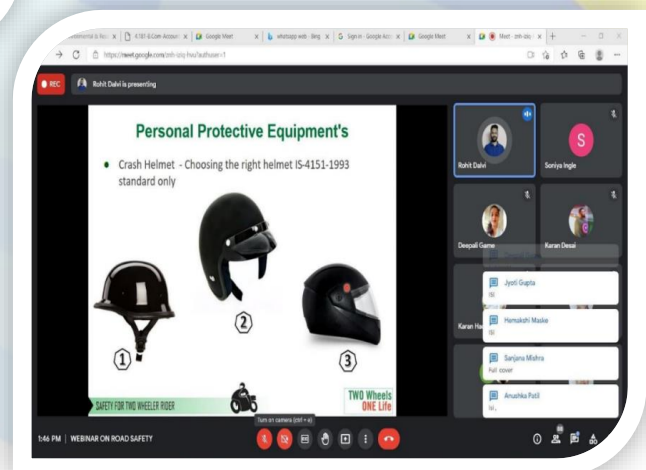
